This journal of ecocriticism is a joint initiative of GIECO (Group for Research on Ecocriticism in Spain) and EASLCE (European Association for the Study of Literature, Culture and Environment). As a virtual space, it provides a site for dialogue between researchers, theorists, creative writers and artists concerned with and by the environment and its degradation.
